ORDINANCES:

Bill No. 9 – Wertz - Amending Bill No. 24, Sessions 2010-2011, of the City Council of the City of Lebanon, Lebanon County, Pennsylvania, designating an area of this city in which new construction of industrial, commercial or other business property and improvements to industrial, commercial or other business property are eligible for a tax exemption pursuant to the Local Economic Development Revitalization Assistance Act, as amended; providing for an exemption on the assessment attributable to the actual cost of such new construction or improvements; providing for the effectiveness of this ordinance, for the purpose of increasing the LERTA exemption for property situate at 900 Maple Street, Lebanon, from five to six years (final reading)

Bill No. 10 - Carey - Increasing the annual salary of Council from \$2,000 to \$3,000 for Council Chairperson and Vice Chairperson and from \$2,000 to \$2,400 for Councilperson in accordance with Section 4, “Salaries”, of Article III, “The Legislative Branch-City Council”, of the *City of Lebanon Home Rule Charter*, effective January 2022 (introduction)

Bill No. 11 – Morales - Increasing the annual salary of the Mayor from \$62,000 to \$75,000 in accordance with Section 5, “Salary”, of Article IV, “The Executive Branch”, of the *City of Lebanon Home Rule Charter*, effective January 2022 (introduction)
