## **Zoning Variance Recommendations:**

• 1507 Willow St.- Seeking variance from ordinance requirement of slaughterhouse maintaining a 400' standoff from adjacent properties. City is concerned with the hygienic upkeep of the facility, possibility increased unpleasant smells and fly activity.

## **Subdivisions & Land Development:**

Lebanon Transit Authority- Plan submissions for this project are nearing completion. SESI and Transit Authority representatives will be in attendance to go over plans and seek approvals to move forward. **New expiration date for this project is 7 January 2026.**

  Work is underway at site. Coordination with PennDOT is ongoing
  concerning the signal permit for 9th & Maple Sts.
- 1041 Maple St. Hutter's- Demolition and reconstruction of site building. Removal of tanks and pumps from flood plain, re-envision plot layout for customer safety and access. New convenience store open, demo of old store nearing completion. New pumps will go in this area. Canopy cover for pump area has been installed.
