Subject: Snow Removal from Narrow Streets/Parking Enforcement/General Snow Information

The City of Lebanon continues to cleanup following Sunday's snow storm. Starting at 7:00 AM each day, City crews will be removing and hauling snow from the following secondary streets in accordance with the following schedule:

- Thursday, January 29<sup>th</sup>- Weidman Street, from Lincoln Avenue to 7<sup>th</sup> Street
- Thursday, January 29<sup>th</sup>- Canal Street, from Lincoln Avenue to 7<sup>th</sup> Street
- Thursday, January 29<sup>th</sup>- New Street, from Lehman Street to Guilford Street
- Friday, January 30<sup>th</sup>- Mifflin Street, from Lincon Avenue to 4<sup>th</sup> Street
- Friday, January 30<sup>th</sup>- Guilford Street, from Lincoln Avenue to 7<sup>th</sup> Street
- Friday, January 30<sup>th</sup> – Brandywine Street, from 11<sup>th</sup> Street to 14<sup>th</sup> Street
- Friday, January 30<sup>th</sup> – Hanover Street, from Federal Street to Walnut Street

All vehicles must be removed from these streets on the days posted. Any vehicle remaining on the designated day posted will be ticketed and potentially towed in order to allow the necessary equipment access.

Common in cities throughout Pennsylvania, Lebanon has an ordinance which prohibits vehicles from parking within the public right-of-way for a period of more than 48 hours. The ordinance applies to all vehicles. Residents need to clean off and dig out their vehicles.

Additionally, we appreciate the residents' hard work this week to shovel out vehicles; however, city ordinance prohibits the placement of obstructions (i.e. orange cones, furniture, or other items) to save a parking spot in the street. Street parking is available for anyone's use and cannot be reserved after cleanup from a snow storm.

Residents are reminded that a path three feet in width, running the entire length of the sidewalk must be cleared from the sidewalk 24 hours after the storm ends. However, due to the significant amount of snow received, Mayor Capello has extended compliance to Thursday, January 29<sup>th</sup> at 4PM.

Enforcement of parking meters and the two-hour free parking lots at 7<sup>th</sup> and Willow and 9<sup>th</sup> and Cumberland Streets have temporarily been suspended through Friday, January 30<sup>th</sup>. Enforcement will resume on Saturday, January 31<sup>st</sup>.
