## CITY OF LEBANON 2023 Spring YARD WASTE COLLECTION SCHEDULE

Collection shall commence Monday, April 17<sup>th</sup> at 7:15 AM Collection will be for one week only in length, ending Friday, April 21<sup>th</sup>

## ALL CITY RESIDENTS ARE TO PLACE YARD WASTE CURBSIDE BY 7:00 AM, MONDAY, April 17th

While we ask that residents have their yard waste placed curbside by the first day of collection, city crews will be working the entire week collecting yard waste. Once city crews have collected yard waste from an area, no additional materials may be placed curbside for collection.

Yard waste materials must be placed in the street, <u>1 foot from the curb for collection</u>. Vehicles must be parked at least 10 feet from the yard waste piles to allow room for city equipment to maneuver while cleaning up the yard waste. Branches longer than 6 feet in length cannot be accepted. Please do not block the storm sewers when placing items curbside for collection. The amount of material per household permitted for collection will be comparable to one pick-up truck size load. Material exceeding this maximum allowed amount or size described will not be collected. In these cases, residents are encouraged to purchase an access card for the Yard Waste Recycling Facility.

Do not place materials curbside until the weekend prior to collection, April 14th – April 16th. In case of rain, this will help prevent the chance of materials being washed into the catch basins and clogging the storm sewer drains. Do not place materials curbside <u>after</u> the city crew has passed your street. The crew will make one pass by each street. If you miss this collection pass, we will not return and consideration to purchasing an access card for the Yard Waste Recycling Facility is recommended.

Collection will include hedge trimmings, branches and garden residue only. Piles of leaves (collected at separate time), lawn grass, ornamental grass and non-organic materials <u>will not be picked up</u>. Please do not place bricks, pavers and other similar items in the piles. Crews cannot see those items under the piles and the items could damage city equipment. Make sure overhead trees have sufficient clearance. It is suggested that all trees are trimmed to a height of 14 feet from street surface for equipment clearance. If you cannot provide an area free of this type of obstruction than your materials should not be placed under low hanging branches or other impediments.

City residents unable to participate in curbside collection may purchase an access card for the City of Lebanon Yard Waste Recycling Facility located at 893 N. 8th Street. The initial fee for an access card is \$40.00 for residential yard waste; there is a \$35.00 annual renewal fee.
